

BAC RESOLUTION DECLARING SCRB AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, after two biddings the University of the Philippines Mindanao, through its Bids and Awards Committee posted the Notice for Negotiated Procurement of the Supply of Appliances, Server, and Office Equipment with an approved budget of One Million Ninety Thousand Eight Hundred Eighty Nine & 88/100 Pesos Only (P1,090,889.88) in the PhilGEPS website, in the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for seven (7) days;

WHEREAS, as a result of such advertisements one bidder, Philcopy Corporation, submitted its price quotation and other requirements upon the deadline on 19 December 2016;

WHEREAS, upon preliminary checking of the required documents submitted by Philcopy Corporation consisting of SEC Registration, Mayor's Permit, Audited Financial Statement, NFCC, Technical Specifications, Bid Form and Certificate of PhilGEPS Registration, the said bidder was found eligible for bidding;
