#### DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE SUPPLY OF SPORTING GOODS AND SUPPLIES FOR 2023 (PBM 2023-21)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Supply of Sporting Goods and Supplies for 2023 with project identification no. PBM 2023-21 consisting of ten (10) lots listed below:

**NOW THEREFORE**, we the members of the Bids and Awards Committee for Goods hereby **RESOLVE** as it is hereby **RESOLVED**:




