BAC-INFRA-CS Resolution No. 32 s. of 2021



### **BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE IMPROVEMENT OF THE SCHOOL OF MANAGEMENT BUILDING PHASE 1 PBM 2021-08INF**

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the IMPROVEMENT OF THE SCHOOL OF MANAGEMENT BUILDING PHASE 1 PBM 2021-08INF with an Approved Budget for the Contract (ABC) in the amount of ₱1,550,748.23 on the PhilGEPS website and the website of UP Mindanao and in a conspicuous place in the University campus for seven (7) consecutive days;

WHEREAS, as a result of such postings two (2) bidders purchased bid documents and submitted their bids on the deadline, June 22, 2021;

WHEREAS, the two bidders submitted their electronic bid proposals, namely Legacy Construction Corporation and 10 Builders and Development Corporation - AVECS Corporation Joint Venture. However, Legacy Construction Corporation's bid is declared ineligible since it has failed to submit a password-protected proposal.

WHEREAS, after preliminary examination of the documents using "pass/fail" non-discretionary criteria, the BAC declared 10 Builders and Development Corporation - AVECS Corporation Joint Venture as compliant with a bid proposal amount of ₱1,470,247.79;

WHEREAS, Section 32.2 of the 2016 Revised IRR authorizes the BAC to evaluate the financial component of the bids to determine the Lowest Calculated Bid;

WHEREAS, after the Technical Working Group and the BAC conducted a thorough evaluation and re-calculation of the bid submitted, it was found that 10 Builders and Development Corporation - AVECS Corporation Joint Venture recalculated bid has a difference of ₱0.01 resulting to ₱1,470,247.80 which is still below the ABC;

WHEREAS, Technical Working Group conducted its Post-Qualification evaluation on the technical and financial documents submitted by 10 Builders and Development Corporation - AVECS Corporation Joint Venture. It was found that their JVA Special PCAB License expired on 30 June 2021.

WHEREAS, based on the report and the recommendation of the TWG and the BAC, 10 Builders and Development Corporation - AVECS Corporation Joint Venture, is found Compliant and hereby declared as Lowest Calculated and Responsive Bid (LCRB). Subject to the submission of renewed JVA Special PCAB License;
