**RESOLUTION NO. 15 SERIES OF 2021**

**DECLARING SINGLE RATED AND RESPONSIVE BID (SRRB) AND  
RECOMMENDING AWARD OF CONTRACT FOR THE INTEGRATED  
CONSULTING SERVICES FOR THE DAVAO CITY- UP SPORTS COMPLEX**

**WHEREAS**, the Bids and Awards Committee (BAC) for Consulting Services has received a Purchase Request for the Integrated Consulting Services for the Davao City-UP Sports Complex with an approved budget for the contract in the amount of Sixteen Million Seven Hundred Eighteen Thousand Eight Hundred Ninety-Three and 23/100 Pesos only (P16,718,893.23);

**WHEREAS**, the Request for Expression of Interest for the said project was posted on the PhilGEPS and UP Mindanao websites and in a conspicuous place within the premises of UP Mindanao from 5 October 2021-10 November 2021;

**WHEREAS**, as a result of the said postings one bidder, Santos Architects and Urban Planners Co. submitted their eligibility documents upon the deadline for shortlisting on 13 October 2021. The BAC found the lone bidder to be eligible;

**WHEREAS**, upon the submission and opening of the Technical Proposal on 10 November 2021, the BAC, using Quality Based Evaluation (QBE) procedure as described in the Bidding Documents, declared Santos Architects and Urban Planners Co. as the Single Rated Bid and therefore qualified for the next round;

**WHEREAS**, on 3 December 2021, upon the successful negotiation with the lone qualified bidder, the BAC proceeded with the opening and reading of the Financial Proposal. The bid was read as Sixteen Million Seven Hundred Eighteen Thousand Pesos (P16,718,000.00) inclusive of taxes, which was within the approved budget for the contract;

**WHEREAS**, after the thorough evaluation of the Technical Working Group (TWG) of the financial component submitted by Santos Architects and Urban Planners Co., the TWG found the financial bid to be compliant as evidenced by the attached TWG Report (Annex A);

**WHEREAS**, on December 28, 2021 the BAC and its TWG conducted the post qualification at the Gaisano Conference Room which included the checking and verification of the bid documents submitted by Santos Architects and Urban Planners;

**WHEREAS**, the TWG signified that the lone bidder passed post qualification as shown in the attached TWG Post Qualification Report dated December 28, 2021 (Annex B);

**NOW, THEREFORE**, we the members of the Bids and Awards Committee for Consulting Services hereby RESOLVE the following:

1. To declare the Santos Architects and Urban Planners Co. as the Single Rated and Responsive Bid (SRRB) for the Integrated Consulting Services for the Davao City-UP Sports Complex;
2. To recommend, for the approval by the Chancellor, the award of the contract for the above-stated project to **Santos Architects and Urban Planners Co.** at a contract price amounting to **Sixteen Million Seven Hundred Eighteen Thousand Pesos (P16,718,000.00)**;






