BAC Resolution No. 06 s. of 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) /LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT FOR VARIOUS LOTS OF THE REBIDDING OF ASIMOV HAWKS PROJECT EQUIPMENT- PBM 2022-01

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid for the Rebidding of Asimov HAWKS Project Equipment consisting of eight (8) lots with a total approved budget for the contract (ABC) in the amount of P5,168,900.00;

WHEREAS, as a result of such postings five (5) bidders purchased bid documents and submitted their bids upon the deadline for submission on March 21, 2022;

WHEREAS, after the preliminary checking of the eligibility and technical requirements the BAC declared all the five (5) bidders to be eligible for bidding, namely:

- 1) Wise 82 Tech Builders Inc.;
- 2) Jassen Harris Industries Corporation;
- 3) iEquity Technologies Corporation;
- 4) Emcor, Inc. and
- 5) Air Prosystems.

WHEREAS, upon opening and checking of the financial envelopes submitted by the five (5) bidders, the following were the bids as read, namely:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by **iEquity Technologies Corporation**, the single calculated bid for Lots 1 and 2, its bid was found to be compliant and responsive to all the requirements for these two lots;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by **Jassen Harris Industries Corporation**, the single calculated bid for Lots 5, 6 and 7, its bid was found to be compliant and responsive to all the requirements for these three lots;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by **Emcor, Inc.**, the lowest calculated bid for Lot 3 – Air Conditioning Units, its bid was found to be non-compliant for the reason that the Omnibus Sworn Statement (OSS) submitted failed to include the following mandatory provision, namely:

ix. In case advance payment was made or given, failure to perform or deliver any of the obligations and undertakings in the contract shall be sufficient grounds to constitute criminal liability for Swindling (Estafa) or the commission of fraud with unfaithfulness or abuse of confidence through misappropriating or converting any payment received by a person or entity under an obligation involving the duty to deliver certain goods or services, to the prejudice of the public and the government of the Philippines pursuant to Article 315 of Act No. 3815 s. 1930, as amended, or the Revised Penal Code. [NEW].

Pursuant to Section 6.4 of GPPB Circular 04-2020, "Non-submission of the Required Forms or non-inclusion of the mandatory provisions in any of the Required forms shall be a ground for disqualification" of the bidder.


WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by **Wise 82 Tech Builders, Inc.**, the single calculated bid for Lot 4 – Biometric Lock Assembly, QR-Based Inventory System and CCTV Kit, its bid was also found to be non-compliant for the reasons stated below, namely:

- 1) The 1st page of the Price Schedule was not duly signed by the authorized representative;
- 2) The mandatory provisions to be included in the Bid Form were not included contrary to what was provided in Sections 6.0 of GPPB Circular 04-2020. Pursuant to the same GPPB circular, the "... non-inclusion of the mandatory provisions in any of the Required forms shall be a ground for disqualification."


NOW THEREFORE, we the members of the BAC for Goods hereby **RESOLVE** the following:

- 1) To declare **iEquity Technologies Corporation** as the single calculated and responsive bid (SCRB) and recommend it for award of the following contracts, namely:
 - Lot 1 with contract amount of P1,147,400.00 and
 - Lot 2 with contract amount of P2,408,800.00;
- 2) To declare **Jassen Harris Industries Corporation** as the single calculated and responsive bid (SCRB) and recommend it for award of the following contracts:
 - Lot 5 with contract amount of P499,800.00;
 - Lot 6 with contract amount of P196,100.00 and
 - Lot 7 with contract amount of P410,000.00;
- 3) To direct the Technical Working Group to proceed with the post qualification on the bid submitted by **Air Prosystems, Inc.**, the next lowest bidder for Lot 3- Air Conditioning Units;
- 4) To notify the post disqualified bidders: Emcor, Inc and Wise 82 Tech Builders, Inc. of their post-disqualification and the reason/s for their post-disqualification;
- 5) To endorse the foregoing for approval by the Chancellor of UP Mindanao.


