

## **BAC RESOLUTION 2017-020**

WHEREAS, the University of the Philippines Mindanao, through the Bids and Awards Committee for Infrastructure Projects, published Request for Bidding the Completion of Football Field and Track Oval: Outdoor Lighting Design, Supply and Installation including Other Facilities with a total approved budget of Seventeen Million Five Hundred Thirty One Thousand Eight Hundred Fifty Four Pesos (P17,531,854.00) on 24 November 2017 in the PhilGEPS and UP Mindanao websites for seven (7) days;

WHEREAS, as a result of this publication, two (2) bidders submitted their bids upon the deadline on 14 December 2017, and upon opening of technical financial component, below were the results:

WHEREAS, after thorough evaluation, of the eligibility and technical documents submitted, AGI Capital Ventures is considered ineligible due to its failure to submit PCAB License and Updated Audited Financial Statement;

WHEREAS, Verzontal Builders, Inc. was found to be eligible, however the TWG findings in their evaluation of the Unit Price Analysis (UPA) and the Bill of Quantities (BOQ) submitted, bods and insurances were included under permits;

WHEREAS, in relation to the above-said findings, the TWG's recommendation was to deduct the amount of Three Hundred Seventy Three Thousand Three Hundred Twenty Pesos (P373,320.00) from the original bid of P17,466,393.52;

WHEREAS, after a series of clarifications made by the BAC and the TWG with the bidder on the recommended deduction of P373,320, Verzontal Builders, Inc. agreed to correct the bid amount; resulting to a final/corrected bid of Seventeen Million Ninety Three Thousand Seventy Three and 52/100 (P17,093,73.52.00) Pesos. Confirmation was recorded in the minutes of the meetings during the December 21, 2017 meeting.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED, to declare Verzontal Builder, Inc. as the bidder with the Single Calculated and Responsive Bid.
