

**BAC RESOLUTION**

No. 2015-28

WHEREAS, the University of the Philippines Mindanao, published the Invitation to Bid for the Supply of Laboratory Equipment consisting of Lot 1 – Colorimeter with an approved budget of Seven Hundred Forty Thousand Pesos Only (P740,000.00) and Lot 2 – Food Processing Laboratory Equipment with an approved budget of One Hundred Sixty-Five Thousand Pesos Only (P165,000.00) in the PhilGEPS website, posted the same in the UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said postings, three (3) bidders purchased bid documents and submitted their bids on October 20, 2015;

WHEREAS, upon preliminary checking of the eligibility and technical documents submitted by the three bidders, all of them were declared eligible for bidding, namely: Fil-Anaserve, Inc., Krypton Industrial Resources Co., and Dakila Trading;

WHEREAS, after opening of the financial proposals the following were the bid prices as read:

WHEREAS, upon a thorough evaluation and post qualification of the eligibility, technical and financial documents submitted by Fil-Anaserve, Inc., the lowest bidder for Lot 1 – Laboratory Equipment (Colorimeter, etc.), their bid was found to be compliant and responsive to the technical specifications and requirements for bidding;


NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve the following:

1. To declare Fil-Anaserve, Inc. as the lowest calculated and responsive bid for Lot 1 with its bid amounting to P580,018.83;
2. To declare a failure of bidding for Lot 2 – Food Processing Laboratory Equipment and recommend that negotiated mode of procurement (small value procurement) be resorted to for this Lot.
