## BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT

No. 2016-35

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee published the Invitation to Bid for the Design and Construction of the Center of Advancement of Research in Mindanao (Phase 2) with an approved budget of P33,409,090.91 in the Manila Bulletin and posted the same on the PhilGEPS website, the UP Mindanao website and in a conspicuous place in the campus for seven (7) calendar days;

WHEREAS, upon the deadline for submission on November 28, 2016 the Bids and Awards Committee received two bids from ASM Francisco Construction & Development Corporation and FFJJ Construction but only ASM Francisco Construction was found to be eligible for bidding;

WHEREAS, after evaluation and pos qualification of the bids submitted by the lone eligible bidder the Bids and Awards Committee passed Resolution 2016-26 declaring failure of bidding; however upon the Motion for Reconsideration from ASM Francisco Construction, the BAC and the Technical Working Group reviewed the bid documents submitted and determined that the conceptual design and other documents of ASM Francisco Construction was substantially compliant; thus the Bids and Awards Committee then passed Resolution 2016-29 nullifying Resolution 2016-26 and also recommending that the BAC proceed with the opening of the financial proposal of ASM Francisco Construction and Development Corporation;

WHEREAS, the BAC, after sending invitation letters to observers, proceeded with the opening of the financial proposal on December 19, 2016 and found that the bid of ASM Francisco Construction amounting to P29,989,797.00 was within the approved budget for the contract;

WHEREAS, after careful and thorough evaluation of the Bill of Quantities submitted, the Bids and Awards Committee declared ASM Francisco Construction and Development Corporoation's bid as compliant and responsive to the requirements;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to recommend the award of the Design and Construction of CARIM 2 contract to ASM Francisco Construction and Development Corporation at a contract price of P29,989,797.00;
