BAC Resolution No. 32 s. of 2022

DECLARING THE LOWEST CALCULATED BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT FOR LOTS 1 AND 2 OF THE SUPPLY AND FABRICATION OF CROWD CONTROL BARRIERS FOR THE DC-UP SPORTS COMPLEX (PBM 2022-22)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Supply and Fabrication of Crowd Control Barriers for the DC-UP Sports Complex (PBM 2022-22) consisting of two lots with a total approved budget for the contract (ABC) in the amount of P1,544,550.00;

WHEREAS, as a result of such postings four (4) bidders submitted their bids upon the deadline for submission on October 12, 2022 at 11:00AM;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the four (4) bidders to be eligible for bidding, namely: Alpha Quality Express Inc., Cabactulan Construction, CCK Builders Construction, and NSB Engineering Design and Fabrication;

WHEREAS, upon opening and checking of the financial envelopes the following were the bids as read listed in the table below, namely:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by the lowest calculated bid (LCB) for Lot 1 and after the actual product demonstration conducted, the Bids and Awards Committee found the bid of NSB Engineering Design and Fabrication for Lot 1 - Crowd Control Barrier (Plastic Defense Barrier) to be compliant and responsive to the technical specifications;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Alpha Quality Express Inc., the lowest calculated bid (LCB) for Lot 2 - Crowd Control Steel Barrier Assembly, the Bids and Awards Committee found their bid to be compliant and responsive to the technical specifications;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby **RESOLVE** the following:

- 1) To declare the following bidders as the Lowest Calculated and Responsive Bid (LCRB) for the lots so indicated and recommend them for award of the contracts listed below, namely:


