### BAC Resolution No. 33 s. of 2022

#### **DECLARING THE LOWEST CALCULATED BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND INSTALLATION OF STADIUM SEATS FOR THE DC-UP SPORTS COMPLEX (PBM 2022-28)**

**WHEREAS**, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Supply and Installation of Stadium Seats for the DC-UP Sports Complex (PBM 2022-28) with a total approved budget for the contract (ABC) in the amount of P11,700,000.00;

**WHEREAS**, as a result of such postings one (1) bidder submitted their bid upon the deadline for submission on November 23, 2022 at 9:00AM;

**WHEREAS**, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared Spurway Enterprises, the lone bidder, to be eligible for bidding;

**WHEREAS**, upon opening and checking of the financial envelope the following was the bid amount as read listed in the table below, namely:

Supply and Installation of Stadium Seats	11,700,000.00	11,421,144.00




