DECLARING FAILURE OF BIDDING OF THE REBIDDING OF THE SUPPLY & DELIVERY OF MULTISPECTRAL CAMERA IMAGING SYSTEM AND IR CAMERA OF AI DURIAN PROJECT (PBM 2024-01)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC) for Goods conducted the Rebidding of the Supply & Delivery of Multispectral Camera Imaging System and IR Camera of AI Durian Project (PBM 2024-01) with an approved budget for the contract in the amount of P2,200,000.00 and posted the Invitation to Bid on the PhilGEPS website, UP Mindanao website, and in a conspicuous place in the campus for seven days;

WHEREAS, due to such postings one (1) bidder, NGSTAR Trading, submitted their bid upon the deadline for submission on 27 May 2024;

WHEREAS, after the opening and preliminary checking of the lone bidder's technical envelope requirements the BAC declared NGSTAR Trading as eligible for bidding;

WHEREAS, on 04 June 2024 upon the presentation of the Technical Working Group's (TWG) report on the evaluation and post qualification of the lone bid, the following were the findings on the Multispectral Camera Imaging System, namely:

- The Bandwidth (FWHM) is 25 nm per brochure provided instead of the required Bandwidth: +/- 7 nm (approx.).
- The Resolution is 4 Megapixel based on its offer of a 4MP Global Shutter CMOS Sensor instead of the required resolution of at least 24 Megapixel.
- The mount and the type of adapter as well as the brand and model of the tripod were for clarification.
- 4. The non-submission of the UP-Devised Technical Specifications Form.

WHEREAS, upon presentation of the rest of the findings of the TWG report the following were the findings for the IR Camera, namely:

- 1. The bid did not include the Accessories: Power Cable, Extra Battery and Micro SD.
- 2. The non-submission of the UP-Devised Technical Specifications Form.

WHEREAS, on 10 June 2024 the BAC sent the bidder a letter requesting for clarification on the above-mentioned findings;

WHEREAS, on 11 June 2024 the bidder clarified that the 24 Megapixel resolution is indicated

in the lens attachment and that for the rest of the items for clarification the bidder informed the BAC that those can be found in the UP-Devised Technical Specifications Form which they attached to their 11 June 2024 letter.

WHEREAS, in another clarificatory letter dated 19 June 2024 NGSTAR Trading confirmed the inclusion of lens attachment with 24 Megapixel resolution for the *Multispectral Camera Imaging System* and attached an unsigned sample quote from Spectra Devices, Inc.

WHEREAS, on 20 June 2024 NGSTAR Trading submitted a datasheet for the Kowa lens (model number LM6FC24M), indicated that a tripod adaptor is included with the camera so it can be mounted on the tripod and stated that the Bandwidth of each filter is approximately +/-7nm.

WHEREAS, the BAC discussed the foregoing TWG findings as well as the responses from the bidder in a series of meetings held on 14 June 2024, 26 June 2024 and 01 July 2024 and agreed that the lone bid is disqualified for the following reasons, namely:

- Although the bidder assured the BAC in its clarificatory letters that their offer has met the required Bandwidth of approximately +/- 7 nm, the brochure submitted during the opening of bids indicated that it was~25 nm which was non-compliant;
- The same is true with the Resolution of 24 Megapixel the brochure submitted during the opening of bids indicated that the resolution is only 4MP;
- For the other item, IR Camera, their bid did not include the Accessories consisting of power cable, extra battery and micro SD;
- 4. Upon scrutiny of the UP-Devised Technical Specifications Form submitted on 11 June 2024, during the post qualification period and not during the opening of bids, the BAC found the same to be unsigned by their authorized representative, thus it cannot be accepted.

NOW, THEREFORE, we the members of the Bids and Awards Committee for Goods, hereby RESOLVE the following, to wit:

- To declare a failure of bidding for the Rebidding of the Supply & Delivery of Multispectral Camera Imaging System and IR Camera of AI Durian Project (PBM 2024-01);
- To recommend that Negotiated Procurement after two failed biddings be resorted to for the next procurement of this project;
- 3. To recommend the above for approval by the Chancellor of UP Mindanao.
