The **UNIVERSITY OF THE PHILIPPINES**, the national university of the Philippines, created by virtue of Act No. 1870, as amended and re-organized and operating by virtue of Republic Act No. 9500, through its constituent unit, the **UNIVERSITY OF THE PHILIPPINES MINDANAO (UP MINDANAO)**, established by virtue of Republic Act No. 7889, with office address at Administration Building, Mintal, Tugbok District, Davao City, represented herein by its Chancellor, **LYRE ANNI E. MURAO, Ph.D.**, hereinafter referred to as the **"THE ENTITY"**;

and

The **HANLINK INC.**, with office address at Door 17 G/F Plaza de Tavera Bldg. Camus Ext., Davao City, represented herein by its Authorized Representative, **LANIE L. DALUZ**, hereinafter referred to as **"THE SUPPLIER"**.

WHEREAS, THE ENTITY invited Bids for certain goods and ancillary services, particularly **Negotiated Procurement (Due to Two Failed Biddings) Supply and Delivery of Multispectral Camera Imaging System and IR Camera of AI Durian Project (PBM 2024-04)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Pesos only (P2,000,000.00)** (hereinafter referred to as **"THE CONTRACT PRICE"**).

iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Negotiation Documents. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
