BAC Resolution Declaring Failure of Bidding of Lot 1- Design Services for the Construction of CARIM Building Phase 2 and Recommending Award of Lot 2 - Design Services for the Improvement and Repair of CSM Research Laboratories

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee, posted the invitation to bid of Lot 1 - Design Services for the Construction of CARIM Building Phase 2 and Lot 2 - Design Services for the Improvement and Repair of CSM Research Laboratories with an approved budget of One Million Six Hundred Twenty Thousand Three Hundred Seventy and 37/100 Pesos Only (P1,620,370.37) and Eight Hundred Twenty Four Thousand One Hundred Sixty Six and 67/100 Pesos Only (P824,166.67), respectively, in the PhilGEPS website and in conspicuous places in the University premises for seven days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted their applications for eligibility and shortlisting but only one (1) bidder, A.C. Ong Consulting, Inc. was found eligible;

WHEREAS, upon detailed evaluation of the technical and financial proposals of AC Ong Consulting, Inc. for Lot 1- Design Services for the Construction of CARIM Building Phase 2 its bid was found to be non-compliant due to the following:

WHEREAS, upon detailed evaluation of the technical and financial proposals of the lone qualified bidder, AC Ong Consulting, Inc. for Lot 2 - Design Services for the Improvement and Repair of CSM Research Laboratories its bid was found to be compliant;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve the following:

- 1) Declare a failure of bidding of Lot 1 Design Services for the Construction of CARIM Building Phase 2 and recommend a second bidding;
- 2) Recommend AC Ong Consulting, Inc. as the winning bidder of Lot 2 Design Services for the Improvement and Repair of CSM Research Laboratories with its bid amounting to Eight Hundred Twenty Thousand Nine Hundred Sixty Pesos Only (P820,960.00).
