WHEREAS, upon thorough evaluation and post qualification of the eligibility, technical and financial documents submitted by Better Components and Gakken Phils., Inc, the two bidders for Lot 8, both their bids were found to be non-compliant and non-responsive to the specifications;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the following:

- 1. Declare Air Prosystems as the Single Calculated and Responsive Bid (SCRB) for Lot 1 and recommend it for award of the contract amounting to P3,267,737.44;
- 2. Declare Gakken Phils., Inc. as the Lowest Calculated and Responsive Bid (LCRB) for Lot 5 and recommend it for award of the contract amounting to P266,887.00;
- 3. Declare failure of bidding for Lots 2, 3, 4, 6, 7, 8, 9, and 10 with a total approved budget amounting to P4,346,200.00 and recommend a second bidding.
