

**BAC RESOLUTION**

WHEREAS, the University of the Philippines Mindanao posted the Invitation to Bid for the 2<sup>nd</sup> Bidding of the Supply of Branded Desktop Computers and Licensed Software with a budget of Five Hundred Seventy Eight Thousand Pesos Only (P578,000.00) in the PhilGEPS website, the UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said advertisements, two (2) prospective bidders purchased bid documents and submitted their bids on May 18, 2015;

WHEREAS, after checking of the eligibility/technical documents of two bidders one bidder was disqualified and only one bidder, GlobalChips Technologies CDO Inc., was found eligible for bidding;

WHEREAS, upon opening of financial proposal and preliminary examination of GlobalChips' bids for the following items the bids as read are shown below:

WHEREAS, after thorough evaluation of the bid documents of GlobalChips Technologies CDO Inc. it was found that the financial bids for the following items are above the approved budget: 1) Branded Desktop Computers and 2) Google Sketch-Up Pro and were thus automatically disqualified;

WHEREAS, upon thorough evaluation of the bid documents of GlobalChips Technologies CDO Inc. for the other items, particularly for the following: 1) Adobe Photoshop Creative Cloud, 2) AutoCAD Software, and 3) Microsoft Office, its bid was found to be compliant and responsive to the specifications;


NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve the following:

  - 3) Microsoft Office amounting to Eight Thousand Pesos Only (P8,000.00).


