GENERAL AGREEMENT

(COMPLETION OF FOOTBALL FIELD: DELIVERY AND INSTALLATION OF SYNTHETIC TURF SYSTEM)

This Agreement is made and entered into by and between:

The **UNIVERSITY OF THE PHILIPPINES**, the national university, created by virtue of Act No. 1870, as amended and strengthened by Republic Act No. 9500, through its constituent university in Mindanao, with principal address at Administration Building, Mintal, Tugbok District, Davao City, represented herein by its Chancellor, **SYLVIA B. CONCEPCION**, **Ph.D.**, hereinafter referred to as the "**UNIVER-SITY**":

and

E-SPORTS RK INTERNATIONAL, INC. an entity duly organized and existing under the laws of the Republic of the Philippines, with address at Unit 204 Alabang Business Tower Acacia Avenue, Madrigal Business Park, Ayala Alabang, Muntinlupa City represented herein by its Managing Director, AUDRIS C. ROMUALDEZ, hereinafter referred to as the "CONTRACTOR".

RECITALS:

- 1. The UNIVERSITY needs to undertake the **Completion of Football Field: Delivery and Installation of Synthetic Turf System** ("PROJECT") with a total approved budget of Thirty Five Million Pesos (P 35,000,000.00).
- 2. The UNIVERSITY, through its Bids and Awards Committee, published the Invitation to Bid for the Completion of Football Field: Delivery and Installation of synthetic Turf System, posted the same in the PhilGEPS website, the UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days.
- 3. As a result of such publication and postings, two (2) bids were submitted and received upon the deadline for submission of bids on August 14, 2017.
- 4. Upon preliminary checking of the eligibility and technical documents submitted by the TWO (2) bidders, all of them were declared eligible for bidding, namely: E-SPORTS RK INTERNATIONAL, INC., and SPURWAY Enterprises.
- 5. The CONTRACTOR, **E-SPORTS RK INTERNATIONAL**, **INC.**, submitted the lowest bid. Upon a thorough evaluation and post qualification of the eligibility, technical and financial documents, its bid was found to be compliant and responsive to the technical specifications and requirements for bidding
- 6. On September 18, 2017, the members of the Bids and Awards Committee resolved to declare E-SPORTS RK INTERNATIONAL, INC. as the lowest calculated and responsive bid and recommended the award of Completion of Football Field: Delivery and Installation of synthetic Turf System contract to it in the amount of Twenty Six Million, Nine Hundred Forty Five Thousand Five Hundred Thirty Pesos & 27/100 (P26, 945,530.27).
- 7. A Notice of Award dated 27 September 2017 was issued to the CONTRACTOR, who has accepted the PROJECT under set terms and conditions, representing itself to be especially competent, skilled, and fully equipped with the necessary materials, manpower and equipment necessary for undertaking the PROJECT;
