BAC Resolution No. 20 s. of 2023

DECLARING 2LCB AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE SUPPLY OF JANITORIAL SERVICES FOR CY 2023 (PBM 2023-06)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Supply of Janitorial Services for CY 2023 (PBM 2023-06) with an approved budget for the contract (ABC) in the amount of ₱4,950,262.21;

WHEREAS, as a result of such postings three (3) bidders submitted their bid upon the deadline for submission on March 28, 2023, namely: Anchor Human Resources Development Corp., Anleo Maintenance & Allied Services Janitorial & Manpower Services and MSIA Employees Development Coop;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the three bidders as eligible;

WHEREAS, upon opening and checking of the financial envelope the following bid amount were deemed within the Approved Budget for the Contract, and declared Anchor Human Resources Development Corp. as the Lowest Calculated Bid (LCB) as shown in the table below:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by the LCB, the Technical Working Group as well as the representatives of the end-user unit found their bid to be post disqualified because upon verification of their experience in providing Janitorial Services, the Bureau of Internal Revenue (Revenue Region No.19- Davao City) certified that they have a completed contract with them for CY 2022 and that the BIR gave Anchor Human Resources Development Corp. a negative assessment;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by **Anleo Maintenance & Allied Services Janitorial & Manpower Services**, the 2LCB, the Technical Working Group as well as the representatives of the end-user unit found their bid to be compliant and responsive to the technical specifications;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- 1) To declare **ANLEO MAINTENANCE AND ALLIED SERVICES** as the Lowest Calculated and Responsive Bid (LCRB) for the Supply of Janitorial Services for CY 2023 (PBM 2023-06) and to recommend the award of the contract in the amount of **₱4,645,988.04** the said bidder; and
