## Description

Invitation to Bid for the Supply of laboratory equipment for the college of science and mathematics

The University of the Philippines Mindanao, through the General Appropriations Act of 2016 intends to apply the sum of Three Million Sixty Six Thousand Pesos Only [P3,066,000.00] being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Laboratory Equipment for the College of Science and Mathematics. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The University of the Philippines now invites bids for the Supply of Laboratory Equipment for the College of Science and Mathematics consisting of six (6) lots. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The University of the Philippines Mindanao will hold a Pre-Bid Conference on November 29, 2017, 9:30 AM at the Conference Room, Administration Building, University of the Philippines Mindanao, Mintal, Davao City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before December 11, 2017, 9:00 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.
