Description

The University of the Philippines Mindanao, through the General Appropriations Act of 2017 intends to apply the sum of One Million Two Hundred Ninety-Four Thousand Eight Hundred Eighty-One Pesos Only [P1,294,881.00] being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Installation of Partitions. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the University of the Philippines Mindanao Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below during hours from 8:00 AM-5:00 PM, Monday-Friday.

Bid opening shall be on November 29, 2017 right after the submission of bids to be held at the Administration Building, University of the Philippines Mindanao, Mintal, Davao City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Only payments in cash or Manager's Check payable to UP Mindanao may be accepted. The University of the Philippines Mindanao reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
